BP America Production Company request permission to surface commingle production the Aztec Pictured Cliffs, Blanco Mesaverde & Otero Chacra Pools from our McCulley LS Wells No. 2A and 8. Surface commingling Aztec Pictured Cliffs production will consist of the McCulley LS Well 8; and Blanco Mesaverde and Otero Chacra production will be from the McCulley LS Well No. 2A. The production from each well will be metered prior to commingling then the commingled production will flow into through the separator where the liquids will be removed. The commingled gas will then be sent through compression prior to entering the sales meter. Please reference the attached schematics reflecting the Current Facilities Layout and the Proposed Surface Commingling Layout provided for your reference.

The working interest, royalty and overriding royalty interest owners in the subject wells are identical. The proposed commingling of production is to reduce operating expenses between the wells and will result in increased economic life of the wells.

BLM has also been notified of this proposal by copy of BLM Form 3160-5.

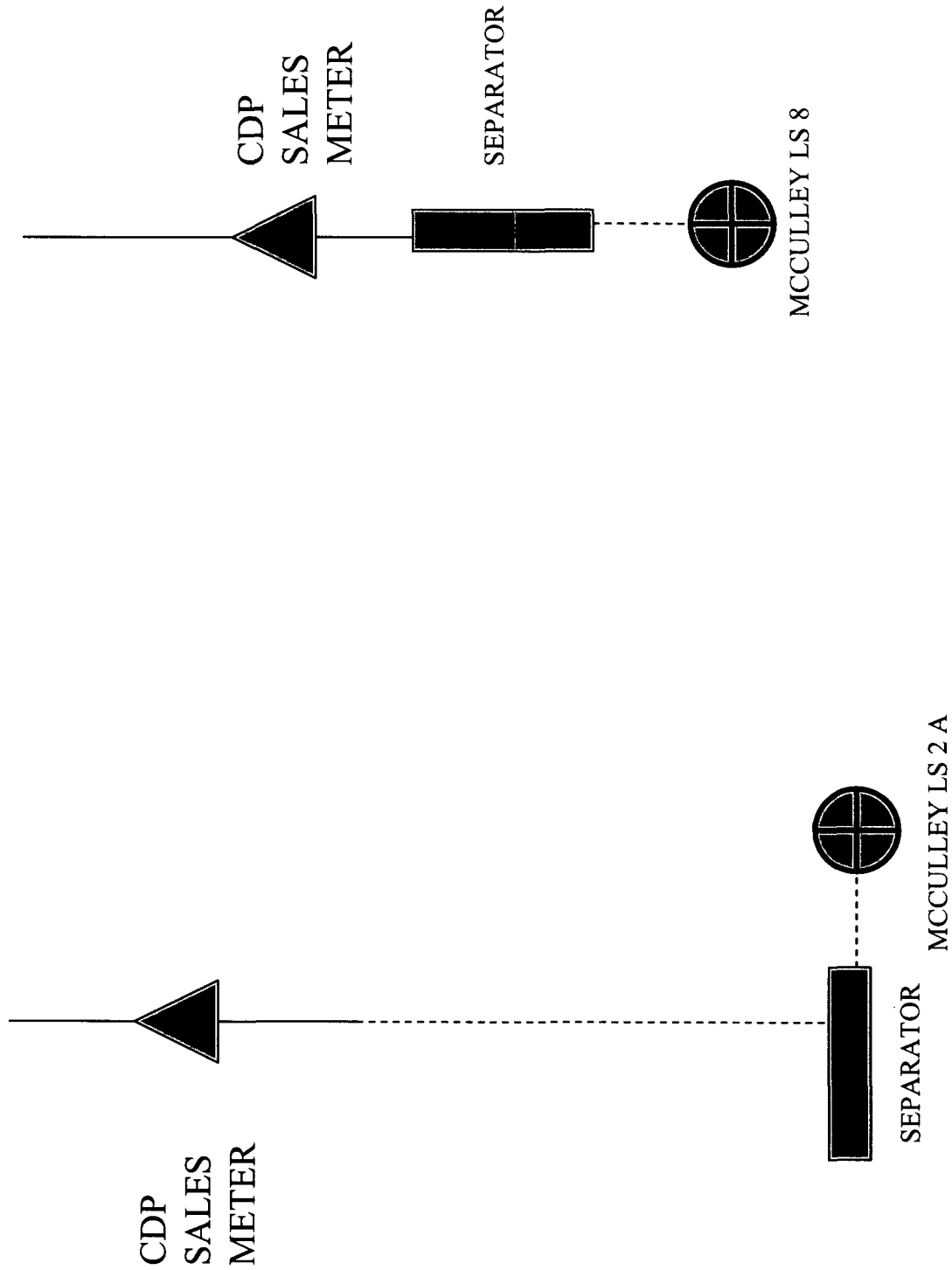
