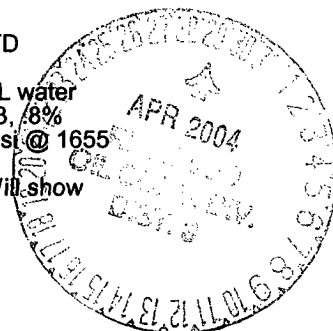

4/12/04 RIH w/6-1/4" bit & tagged TOC @ 2889'. D/O cement & then formation to 7780' (TD). TD reached 4/16/04. Circ. hole. RIH w/4-1/2", 11.6#, N-80 LT&C casing and set @ 7776'. RU Halliburton to cement. Pumped a preflush of 20 bbls 2% KCL w/chemical wash, 10 bbls 2% KCL water ahead of 470 sx (681.5 cf - 121.4 bbl slurry) 50/50/POZ w/3% gel, 3.5#/sx Phenoseal, .2% CFR3, .8% HALAD 9, .1% HR-5. Dropped plug and displaced w/118 bbls 2% KCL. Bumped plug w/1750 psi @ 1655 hrs 4/16/04. RD Halliburton. ND BOP, set slips and cut off casing. Installed trash cap. Ran TOTCO wireline survey @ 7773'. Tag TOC @ 7773'. RD & released rig @ 2400 hrs 4/16/04. Will show casing PT & TOC on next report.
