Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped 440 sx (204.5 bbls 1147.9 cf) Class G cement w/3% Extender, 0.25#/sx Cellophane, 0.2% Antifoam. Tail - 100 sx (22.5 bbls - 127 cf) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2% CaCl2, 0.25#/sx Cellophane, 0.2% antifoam. Released wiper plug and displaced plug w/134 bbls FW. Circ. 20 bbls good cement to surface. RD Schlumberger. ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig 10/25/03. Will show casing PT on next report.
