Bumped plug w/300 psi. Circ. 8 bbls cement to surface. RD Schlumberger. WOC. NU WH & BOP. PT-OK. PT blind drams, WH/casing connection and casing to 375 psi for 2 minutes and 1225 psi for 30 minutes.
