We have submitted the following commingle allocation percentages to the State (DHC-1324AZ) for this MV/DK well. The Dakota was 1st delivered in September 2003 and the Mesaverde was added in March 2004. The gas allocations are based on each formation's separate test, which was taken during completion operations. The Oil allocations are based on actual oil production both before and after the Mesaverde was added to the production stream.
