In a follow up to the Sundry Notice dated 7/23/02 and that was approved by the BLM on 7/28/02, a 4 1/2" CIBP was set at 4290'. The Gallow B was then perforated and fraced at 4160 to 4210 as well as the Gallow A at 3910' to 3920'. Scrubbed 2 barrels of oil and with gas blow after scrub down, put on pumping unit on 9/20/02.
