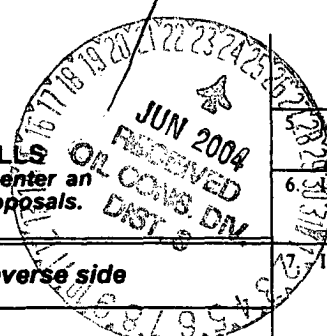

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomplate horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. In a follow up to the sundry notice dated 7/23/02 and that was approved by the BLM on 7/28/02, a 4 1/2" CIBP was set above the GALLUP "B" at 4330' and perforated. Acidized and fraced the GALLUP "A" at 4130 to 4140 and 4010 to 4030; Stimulated only water and with only a trace of oil and gas on 9/15/02.

A mechanical Integrity Test was then performed successfully on 9/23/02 and was witnessed by Rick Romero of the BLM, Cuba, NM Office and by Johnny Angel Pride Energy Company's consultant. A New Mexico Oil Conservation Division representative was not available for the witness of the MIT. The well was then temporarily abandoned.
