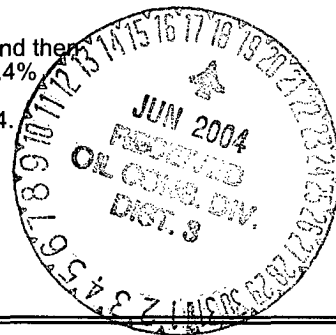

Pumped a preflush of 10 bbls FW, 10 bbls chemical wash, 10 bbls FW and then Pumped Lead - 394 sx (839 cf) Premium Lite, w/0.4% FL-52, 5.0#/sx LCM-1, 0.25% Cello-flake, 0.4% Sodium Metasilicate, 8% Bentonite, & 3% CaCl₂. Tail - 90 sx (124 cf) Type 3 w/1% CaCl₂, 0.25% Cello-flake, 0.2% FL-52. Dropped plug and displaced. Bumped plug w/1300# @ 0715 hrs 5/28/04. Circ. 68 bbls cement to surface.
