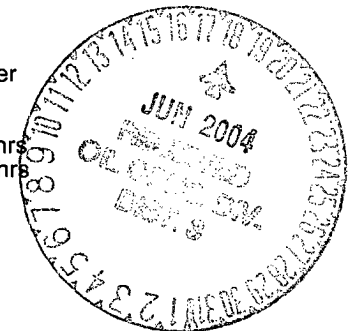

Pumped a preflush of 10 bbls water, 10 bbls chemical wash, 10 bbls water ahead of Lead - 328 sx (640 cf - 124 bbls) Premium Lite, w/0.4% FL-52, 5.0 #/sx LCM-1, 0.25% Celloflake, 0.4% Sodium metasilicate, 8% bentonite, & 3% CaCl₂. Tail-90 sx (113 cf - 122 bbls slurry) Type 3, w/1% CaCl₂, 0.25% Cello-flake, 0.2% FL-52. Bumped plug w/1400 psi @ 0725 hrs 5/24/04. Circ. 30 bbls cement to surface. ND cement head, ND BOP. RD & released rig 1430 hrs 5/24/04. Will show casing PT on next report.
