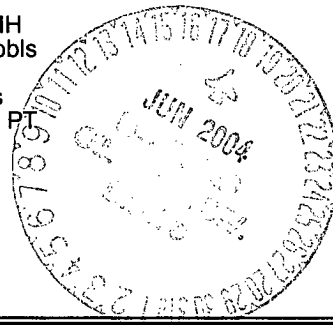

Pumped a preflush of 20 bbls water ahead of Lead - 11 sx scavenger cement (26 cf - 4.6 bbl slurry). Tailed w/300 sx (384 cf - 67 bbls) Type III cement w/.25#/sx Cello-flake, 3% CaCl<sub>2</sub>. Dropped plug and displaced w/23 bbls water. Plug down @ 0213 hrs 6/11/04. Circ. 5 bbls cement to surface. RD BJ. NU WH & BOP. PT blind rams and casing to 600 psi for 30 minutes. Good test.
