Pumped a preflush of 20 bbls water & 10 bbls chemical wash ahead of Lead - 303 sx (595 cf - 115 bbls slurry) Premium Lite w/0.4% FL-52, 5.0#/sx LCM-1, 0.25% Celloflake, 0.4% Sodium metasilicate, 8% Bentonite, & 3% CaCl2. Tail - 90 sx (22 bbls) Type 3 w/1% CaCl2, 0.25% Celloflake, 0.2% FL-52. Dropped & bumped plug w/1300 psi @ 1206 hrs 5/31/04. Circ. 20 bbls cement to surface. RD BJ. ND to move.
