We drilled 12 1/4" hole to 180', and ran 8 5/8", 24#, J-55, ST&C Casing, landed @ 176.21 KB (KB=5'0"). Cemented casing on 6/9/04 with 162 sks Class B Cement, plus 2% CACL2 plus 0.25 lb/sk Celloflake, 15.6#, yield 1.18, 191 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 12 bbls of good cement to surface. Wait on cement overnight +/- 17 hours.

On 6/10/04, pressure tested casing and BOPs to 750 psi for 30 minutes. Held O.K.
