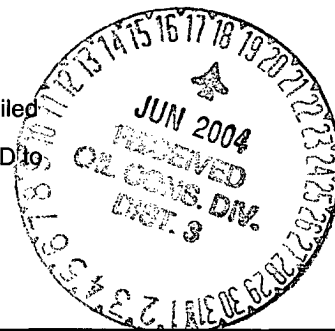

Tailed w/90 sx (124 cf - 22 bbls) of Type III w/1% CaCl₂, 0.25% Celloflake, 0.2% FL-52. Dropped plug & bumped w/1300# @ 2300 hrs 6/3/04. Circ. 16 bbls cement to surface. RD BJ.
