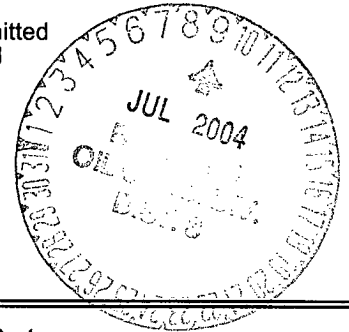

Final review indicates that there is no uphole potential and BP intends to submit recommendation to plug and abandon. Plugging procedure is being formulated and will be submitted to your office for approval within 30 days. Plugging operations will commence upon your approval and working interest partner approval.
