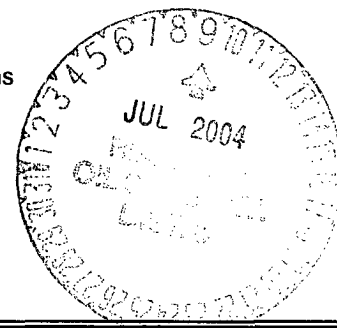

Please reference BLM letter of March 04, 2004, and our Sundry NOI of April 15, 2004, indicating we intended to hold the well in a shut-in status pending evaluation of uphole potential in the Fruitland Coal formation. Results of that review indicates that there is no uphole potential, therefore, it is our intent to plug and abandon the well bore. Plugging procedures are being formulated and will be submitted for your approval within the next 30 days. Plugging operations will commence upon receipt of your approval and working interest partner approval.
