7/17/04 MIRU. Spud well. Drill 130' of new 8 3/4" hole to 130'. TOH with DP/DC and bit. Run 126' of 17# H-40 surface casing. Land surface casing at 127' - 1' GL. Cement surface casing with 60 sx Class B cement with 3% CaCl<sub>2</sub>, 1/4#/sk celloflake, 15.60ppg, 1.18 yield. Circulate 4 bbl to surface. WOC. Secure rig, SDFN.

7/18/04 Rig broke down. Work on rig.

7/19/04 NU BOP. Test BOP and surface casing to 600psi, held OK. Drill 674' of new 6 1/4" hole to 804'. Run wireline survey at 510' = 1/2 degree. Secure rig, SDFN.

7/20/04 Drill 631' of 6 1/4" hole to 1437'. TD well. Run two wireline surveys at 1100' = 1/2 degree, and at 1415' = 3/4 degree. Secure rig SDFN.

7/21/04 TOH with DP/DC and bit. Run 1431' of 4 1/2" 10.5# J-55 production casing. Land production casing at 1431' + 1' GL. Cement production casing with 115 sx Class B cement with 2% Sodium Metasilicate, 3#/sk gilsonite, 12.50ppg, 2.06 yield, as lead. Tail in with 50 sx Class B cement neat, 15.60ppg, 1.18 yield. Circulate 10 bbl to surface. Bump plug with 1000psi, shut in. WOC.
