

TIH & ran 5 1/2" 15.5# J-55 CSG to 2354'. Cement scavenger w/13 sxs cmt; Density 10.30 ppg; Yield 4.460 cuft/sk. Lead w/252 sxs class G cmt; Density 11.70 ppg; Yield 2.610 cuft/sk. Tail w/105 sxs cl G cmt, Density 13.50 ppg; Yield 1.260 cuft/sk. 1 bbl good cement to pit. Shut pipe rams & tst to 500#. Held press 5 min. NDBOP. Released rig @14:00 hrs 7/10/04.
