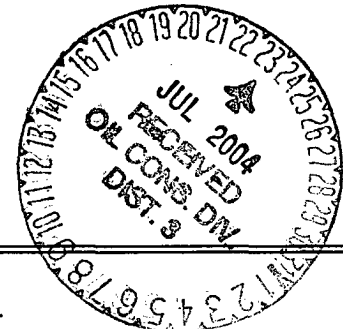
Production from this well has not reached the original anticipated volume, which we believe is in part due to the original fracture treatment.

We intend add perfs in coal seams as follows 1848'-1850', 1932'-1934', and 1968'-1970' 4 spf (8 holes per interval), 24 holes total, 0.35" diam. Then we intend to re-fracture this well in a single stage 70Q Nitrogen foam frac with 275,000# 20/40 Brady sand.

We will use a blow back tank for returns, so no pit will be required. All equipment will be placed on the existing well pad.

We plan to begin work July 22, 2004, due to rig availability.
