

Drilled 6 3/4" hole to 2235', and ran 4 1/2", 10.5#, J-55, ST&C Casing, landed @ 2230.10' KB (KB=5'0"). Cemented on 6/22/04. Lead cement pumped 230 sks 12.5# Class B Cement w/ 2% Sodium Metasilicate, plus 3#/sk Gilsonite, plus 2#/sk PHENOSEAL, plus .25#/sk Celloflake, yield 2.09, volume 480 cu. ft. Tall with 55 sks 14.5# Class B Cement, plus 1% gel, plus 2% CALC, plus 3#/sk Gilsonite, plus .25#/sk Celloflake, yield 1.4, volume 77 cu ft.. We used centralizers on the bottom 2 joints, and every +/- 400' thereafter. Used 2 turbolators, 1 at the base of the Ojo, and the other in the Ojo. Circulated 8 bbls of good cement to surface. Wait on cement +/- 14 hours.
