

Please reference BLM letter of March 04, 2004. On April 15, 2004, we submitted a Sundry NOI of our intent to review the subject well for possible uphole recompleat. Prior to attempting an uphole recompleat BP intends to perform a 3 day flow test to evaluate for compression within the next 30 days; results will determine if a 30 compressor test will be done in the next 3 months.
