Set CIBP at 3450' and cap w/50' of cmt. Spot cmt plug inside 5 1/2" casing from 3172' to 3022', 17 sx.

Spot cmt plug inside 5 1/2" casing from 2685' to 2535'. 17 sx.

Perforate casing at 1980'. Set cmt retainer at 1830'. Squeeze under retainer w/adequate cement to cover 1980' to 1830', behind 7 5/8" casing & inside 5 1/2" casing. 68 sx.

Perforate casing at 641' and set cmt retainer at 501'. Squeeze under retainer w/ adequate cmt to cover 641' to 501'. behind 7 5/8" casing and inside 5 1/2: casing. 68 sx.

Perforate at 221'. Establish circulation to surface and circulate cmt to surface. 100 sx.

Cut off wellhead and install dry hole marker. Clean up surface.
