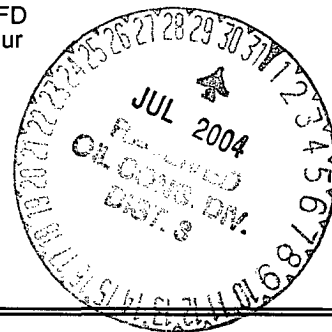

The subject well was restored to production on June 16, 2004 producing approximately 100 MCFD through the end of June. The well has since decline to a rate of approximately 25 MCFD. It is our intent to rig up and run diagnostics on the well in an attempt to restore production to an economical rate.
