TOO H w/tubing & inspected. TIH w/bailer. Hydrotested 2-3/8" tubing to 5000# - OK. C/O fill to 3430' (new PBTD). TOO H w/bailer. RIH w/2-3/8" tubing and landed @ 3421' w/SN @ 3394'. ND BOP, NU WH. RIH w/RWAC-Z pump & rods. Spaced out. Load tbg & test to 1200# - OK. Test pump to 500# - OK. Set prod. equip to pumping. RD & released rig 4/9/04.
