Cored HQ (3-895") hole to 2555' total depth on 14 June, 2002. Left 3.5" O.D. HQ rod fish in hole from 1242' to 2465'. Was unable to get inside fish with 2.75" O.D./NQ rods to cement lower portion of hole due to damage from string shot used to blast off stuck pipe. Set cement plug in HWT casing (4" I.D.) from 5' to 205' and open hole (HQ/3.895") from 205' to 1242'. Cemented hole with 70 sx/91 ft.³ Class A neat cement with good returns to surface on 18 June, 2002. Backfilled cellar & mud pits, smoothed over disturbed area, and installed abandonment monument on 19 June, 2002.

Although present site condition satisfies permit requirements, the site will be re-smoothed in the mud pit area (following expected settling) in August and seeded and raked over following final leveling.
