Drilled 12-1/4" hole to 305'. On 6/3/2004, set 6 jts 9-5/8" 32.3# casing at 296'. Cemented with 175 sx (42 bbls) Class "B" cement w/ 1/4# Flocele and 2% CaCl2. Circulated 15 bbls to surface. Tested casing to 1500 psi.

Drilled 8-3/4" hole to 3533'. On 6/6/2004, set 105 jts 7" 23# casing at 3527'. Cemented with 475 sx (122 bbls) 50/50 Poz with 2% Gel, 0.2% Versaset, 0.1% Diacel. Foamed slurry with Nitrogen. Tailed in with 75 sx (19 bbls) same slurry without nitrogen. Circulated 30 bbls cement to surface. Tested casing to 1500 psi.

Drilled 6-1/4" hole to 7995'. On 6/8/2004, set 189 jts 4-1/2" 11.6# casing at 7991'. Cemented with 235 sx (61 bbls) 50/50 Poz with 2% Gel, 0.2% Versaset, 0.1% Diacel. Foamed slurry with Nitrogen. Tailed in with 450 sx (117 bbls) Class "B" w/ 3% Gel, 1.4% Halad-9, 0.1% CFR-3, 5# Gilsonite, and 1/4# Flocele. Circulated 10 bbls to surface. Tested casing to 4500 psi.
