2nd stage lead cmt: 305sx 65/35/B POZ, 8% gel, 5# gilsonite, 1/4# flocele, 2% CaCl, 12.10 ppg, yield 2.11 cuft/sk, water 10.98 gal/sk.

2nd stage tail cmt: 50sx Class B, 2% CaCl, 5# gilsonite, 1/4# flocele, 15.2 ppg, yield 1.28 cuft/sk, water 5.28 gal/sk.

Drill out DV tool. Drill 6 1/4" hole to TD @8167'. TD on 4/21/04. TIH w/42 jts. 4 1/2" 11.6# N-80 csg and 145 jts. 10. 5# J-55 csg. Set @ 8163'.

Cement w/25 bbls Chemwash, 5 bbls H2O, 513 sx 50/50 POZ, 2% gel, 8% Halad 9, 0.2% HR5, 0.2% CER 3, 5# gilsonite, 1/4# flocele, weight 13.5 ppg, yield 1.31 cuft/sk, water 5.23 gal/sk.
