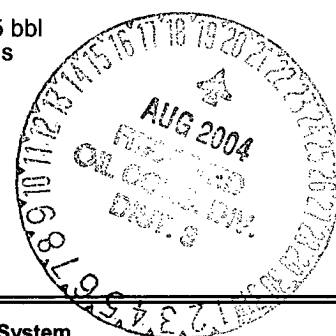

Pumped 4 bbls H2O ahead of 50 sx (81 cf - 14.5 bbl slurry) Type I-2 cement w/205 Flyash. Dropped plug and displaced w/7.8 bbls H2O. Circ. 1/2 bbls to surface. Plug down @ 10:30 hrs 8/13/04. The drilling rig will conduct the 9-5/8" casing PT before it continues with drilling operations. Will show casing PT on next report.
