On 7/9/02 BP America requested permission to DHC subject well. Approval was granted 8/2/02 (DHC 837AZ)

On 8/11/04 BP America requested permission to plug and abandon the subject well and permission was granted on 8/12/04.

It is currently planned to pressure test the production casing and prepare to DHC. However, in the event the DHC is not possible the well will be P&A'd as per the approved plugging procedure. In either event BP will call both the BLM and the NMOCD to advise of our proceedings.
