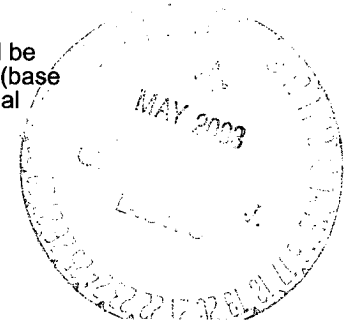

ConocoPhillips proposed to deepen the subject well to allow for sump/rathole in non-producing Pictured Cliffs formation.

Plans are to have a mudlogger on site to verify that PC gas isn't encountered and mud logs will be run and faxed to BLM for their verification. The maximum depth we would deepen is to 3591' (base of basil coal). If PC gas is encountered in the process, we will plug back to the base of the coal interval.
