NU 1-1/4" x 16' polish rod & 1-1/4" x 8' heavy polish rod liner & seat pump. NU stuffing box. Load hole w/ 5-Bbbs 2% KCl water & pressure to 200# w/ rig pump, OK. Stroke pump & pressure pump and tubing to 600#, OK. RD Key Rig #12. Shut-in, secure well & location.
