Bullhead water into well to ensure that the well will take water and that no water comes out the bradenhead.

If both conditions are met, then we will bullhead cement from the bottom perfs to the surface.

Then we will circulate cement from 150 feet to the surface outside the production csg using 3/4" pipe.

Before we do this we will establish that we can get 3/4" pipe to 150' and can circulate. IF not will plug
