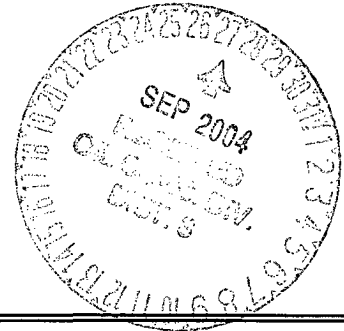

It is intended to deepen the existing Basin Fruitland Coal well to approximately 3308' into the Pictured Cliffs formation. It is anticipated the Pictured Cliffs is not productive in this wellbore. The existing tubing and liner will be pulled. The hole will be circulated clean. Additional footage will be drill (approximately 85' below current total depth or last significant coal) and again the hole will be cleaned. The well will then be reconfigured with a 5 1/2" 15.5# J-55 liner set at approximately 3058-3308'. A mud logger will be utilized to monitor any Pictured Cliffs gas.
