Verbal approval given by Mr. Steve Wells (BLM Engineer) to set a CIBP at +/- 3705' with 2 sx sand and test to 2000 psig. Purpose of CIBP was to isolate shoe leak to be able to pressure test casing.

Pressure test casing on 10/15/2003 to 1900 psi.
