Drill 12-1/4" hole to 294'. On 3/5/03 ran 8 jts 9-5/8" ST&C 32.3#, H-40 surface casing. Set at 285'. Cement with 175 sacks (37 bbls) Class "B" cement, 2% CaCl, 1/4# PSX Floseal, yield 1.18. Circulate 19 bbls cement to surface. Pressure test casing to 1500 psi.

Drill 8-3/4" hole to 3747'. On 3/9/03 ran 7" J-55, 23# LT&C casing. Set at 3738'. Cement with Lead: 475 sacks (122 bbls) 50/50 POZ, 13.0#, yield 1.44, 2% gel, .2% versaset, .1% diacel LWL. Tail in with .75 sacks (19 bbls) 50/50 POZ, yield 1.44, 2% gel, .2% versaset, .15 diacel LWL. Circulate 35 bbls cement to surface. Pressure test casing to 1500 psi.

Drill 6-1/4" hole to 8127'. On 3/13/03 ran 4-1/2" J-55 LT&C 11.6# casing. Set at 8083'. Cement with 605 sacks (158 bbls) 50/50 POZ "B", yield 1.47. 3% Gel, 1.4% Halad-9, 0.1% HR-5, 0.1% CFR3, 5 ppsx gilsonite, 1/4 ppsx Flocele. Circulate 20 bbls water and chem. wash to surface. Pressure test casing to 4500 psi. Top of Cement: 1200'.
