A service rig was rigged up on the subject well to downhole commingle. The Model "R" production packer was removed from the wellbore and the well was cleaned out to PBTD at 8680'. The 2-3/8" production tubing was then run back in well and landed at 8548'. The well was then turned to sales as a downhole commingled Dakota/Mesa Verde producer.
