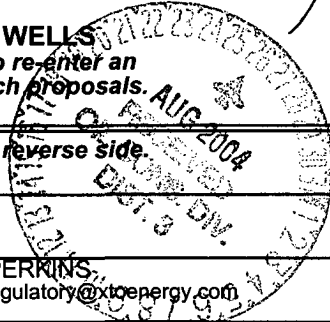

Intermediate: 8-5/8", 32#, J-55 LTC csg set @ 4152' in 12-1/4" hole. Cmt w/950 sx type III w/extender, accelerator & LCM (11.4 ppg, 3.03 cuft/sx) followed by 150 sx type III w/accelerator & LCM (14.5 ppg, 1.41 cuft/sx). Circ cmt to surf.

Long string: 5-1/2", 17#, J-55, LTC csg set @ 7200' in 7-7/8" hole. Cmt w/325 sx Prem Lite HS w/dispersant, fluid loss & LCM (12.5 ppg, 2.01 cuft/sx) followed by 150 sx Class H w/dispersant,
