XTO Energy Inc. requests approval to change the casing design as originally proposed in the AFD. The new casing design will be as follows:

Surface Casing: 9-5/8", 36.0#, J-55, STC set @ 360' in a 12-1/4" hole. Cement with +175 sx Type III cement with accelerator and LCM mixed @ 14.5 ppg & 1.41 cuft/sx. Circ cement to surf.

Production Casing: 5-1/2", 15.5#, J-55, STC casing set 5,000' in a 7-7/8" hole. DV Tool set @ 3,850'. Cement first stage with +150 sx Premium Lite HS cement containing dispersant, gel, fluid loss and LCM typically mixed @ 12.5 ppg, 2.01 cuft/sx.

Cement second stage with (lead) +300 sx Type III with 8% gel, & LCM typically mixed at 11.4 ppg & 3.03 cuft/sx followed by (tail) 50 sx Type III cement neat typically mixed @ 14.5 ppg & 1.41 cuft/sx. Circ cement to surf.
