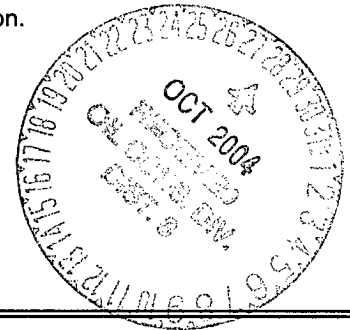

Plug down @ 12:30 pm on 10/16/04. Circulate 7 bbls cement to surface. WOC. RD Halliburton. Test casing & BOP to 600 psi - ok.
