Pull 1" tbg. Set 5-1/2" BP @ 1100'. Perf 5-1/2" csg @ 1050' & attempt to circ. cmt out bradenhead. Drill & CO to new TD 2300'. Run CNL log. Land 3-1/2" 9.3# N-80 csg @ 2300' & cmt (288 cf) to surface. Perf PC @ ~2165'-2265' & frac w/110,000# sand in 70Q foam. Clean out to PBTD. Run 1-1/4" tbg & complete as a single PC gas well.

CONDITIONS OF APPROVAL

Adhere to previously issued stipulations.

Note: If cement fails to circulate out the bradenhead, contact this office prior to running 3 1/2" csg.
