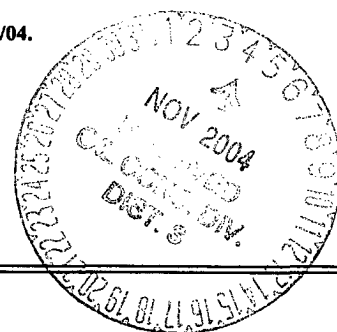

Cemented csg w/ 251 sx (698 cuft) Cl "B" cmt + 3% Sodium Metasilicate + 3#/sk Gilsonite + 2#/sk Phenoseal + 1/4#/sk Celloflake lead slurry (11.5 ppg), 92 sx (108 cuft) Cl "B" cmt + 4% Gel + 3#/sk Gilsonite + 2#/sk Phenoseal + 1/4#/sk Celloflake tail slurry (14.1 ppg). Circulated 8 bbls cmt to surface. Plug down at 12:30PM, 10/6/04.

Ran cased hole Gas Spectrum Log from PBTD at 2325' to 1000' and CBL from TD to surface on 10/12/04.
