It is intended to restimulate the Pictured Cliffs formation in the subject well as follows:

Move in, rig up. Pull tubing. Deepen the well to approximately 2400'. Run 2-7/8" 6.4# J-55 EUE csg, to total depth. Cement 2-7/8" casing with 125 sacks lead cement (yield of 2.13 cu.ft per sack, 12.10 ppg). Tail with 35 sacks cement (yield of 1.47 cu.ft per sack, 14.20 ppg). Fracture stimulate the Pictured Cliffs formation. Return well to production.
