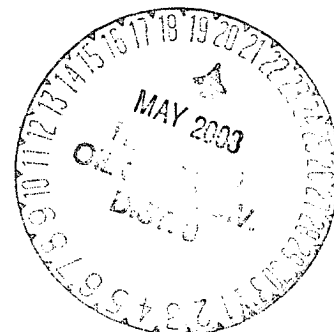

Plans have changed from the original BOP design submitted with the APD. The current configuration from a 11" 3000# Double BOP with blinds on bottom & pipe rams on the top will be changed to an 11" 3000# single BOP with blind rams below an 11" Hydril ~~Annular~~ BOP, capable of closing on all pipe configurations COP is currently utilizing. The annular BOP will be tested to 1500 psi.
