



Based on Burlington's interpretation of the OCD's risk ranking criteria, the new drilling pit and blow/flare pit will be an unlined pit as detailed in Burlington's Drilling / Workover Pit Construction / Operation Procedures dated April 26, 2004 on file at the NMOCD office. A portion of the blow/flare pit will be designed to manage fluids, and that portion will be unlined, as per the risk ranking criteria. Burlington Resources anticipates closing these pits according to the Drilling / Workover Pit Closure Procedure dated August 2, 2004 on file at the NMOCD office.
