Cmt first stage w/180 sx Prem Lite cmt w/dispersant, fluid loss & LCM (12.5 ppg, 2.01 cuft/sx) followed by 150 sx Class H w/dispersant, fluid loss & LCM (14.2 ppg, 1.54 cuft/sx). TOC should be @ or above the DV tool. Cmt second stage w/200 sx premium Lite HS cmt w/dispersant, FL & LCM (12.5 ppg & 2.01 cuft/sx) followed by 250 sx Type III w/gel & LCM (12.5 ppg & 2.01 cuft/sx) followed by 250 sx type III w/gel & LCM (11.4 ppg & 3.03 cuft/sx). Circ cmt to surf.
