Drilled 12 1/4" hole to 305' on 09/28/04, set 5 jts of 9 5/8", 32.3# casing at 294'. Cemented w/175 sx (36 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 10 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3074' on 10/01/04, set 67 jts of 7", 23# casing at 3063'. Cemented lead w/525 sx 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx STD, 4/10% Halad 344. Circulated 9 bbls of cement to surface. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 3422' TVD. Underreamed hole to 9 1/2" from 3070' to 3412'. Utilized natural and air assisted surges to remove near wellbore material. On 10/15/04, set 11 jts 5-1/2" 15.5# liner at 3400' with JGS liner hanger at 2968'. Perforated liner with 96 0.48" holes from 3098'-3245'. Landed 2 3/8" production tubing at 3258'.
