We request an extension of time for the APD on this well. We have been unable to secure drilling equipment to drill this well due to a lack of rig availability. We have been on drilling contractors waiting lists since late 2003 but major operators have contracted all the rigs. When rigs have been available the forest service access restrictions (November through March shutdown) have prevented us from drilling the well.

The location for this well has been built and is ready for a rig once one is available after April 1st forest opening. We plan to drill the well as soon after April 1, 2005 as possible.
