Began workover procedures. Released packer. Set RBP at 1260' and set packer at 1215'. Pumped 20 bbls water down tubing and did not catch any pressure or circulate well. Reset RBP and reset packer at 1246'. Pumped another 6 bbls water down tubing but still did not pressure tubing.

Released packer.

Reset RBP at 1230'. Set packer at 1185'. Pressure would leak off to 1000# in 1 min, 750# in 2 min and 500# in 4-5 mins. Released packer and reset RBP at 644'. Loaded annulus and pressure tested casing to 500#, held OK. Released packer and RBP. Set a 4-1/2" CIBP at 910'. Pumped 100 sx Halliburton Lite (65/35 poz with 6% gel) with 1% CaCl2 and 100 sx "B" with 2% CaCl2. WOC. Pressure tested squeeze to 500 psi, held OK. Milled 7" of CIBP in 45 min. Finished drilling CIBP. Pushed remains of plug to approx 1626' (bottom perf at 1326').
