**Drilled 8 3/4" hole to 3,625' on 09/06/04, set 80 jts of 7", 23# casing at 3,612'. Cemented lead w/525 sx (135 bbls) 50/50 POZ w/2% Gel, 2/10% Versaset & 1/10% Diacel LWL and tail w/75 sx (18 bbls) 50/50 POZ w/2% Gel, 2/10% Versaset & 1/10% Diacel LWL. Circulated 10 bbls of cement to surface. Tested casing to 1500 psi.**

**Drilled 6 1/4" hole to 8,117' on 09/09/04, set 183 jts 4 1/2" casing at 8,112'. Cemented lead w/235 sx (60.6 bbls) 50/50 POZ w/2% Gel, 2/10% Versaset, 1/10% Diacel LWL and tail w/450 sx (124.5 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface. Landed 2 3/8" production tubing at 8,034'.**
