XTO Energy Inc. requested and received approval for surface commingling on the Stanolind Gas com B #1 CDP (PLC-236) on 11/8/04 from the NMOCD and 12/8/04 verbally from Jim Lovato at BLM. We had originally submitted our application for commingle of a Basin Dakota (Stanolind Gas Com B #1) and a Basin Fruitland Coal (Stanolind Gas Com B #3). We now discover that the Stanolind Gas Com B #1 is a Blanco Mesaverde reservoir and is to be commingled with the Stanolind Gas Com B #3, a Basin Fruitland Coal. We have included with our change to the application the appropriate changes in each attachment needed for the application and request that you approve our change as soon as feasible so we may proceed with commingle of these wells. The NMOCD has also received our amended application.
