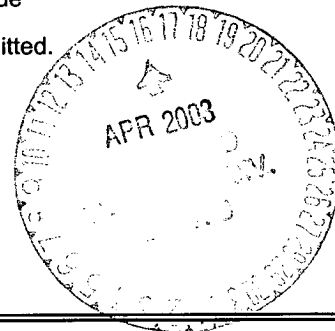

It is intended to add the Mesaverde formation to the subject well by pulling the existing Dakota tubing. The existing Dakota formation will be isolated using a cast iron bridge plug. The Mesaverde formation will be perforated and fracture treated. Production tubing will be run. The well will then be returned to production as a commingle. A down hole commingle application will be submitted. A C-102 plat is attached.
